

**Response to the Electricity pricing review a vote of confidence in the Electricity Authority**

The Government released its response to the Electricity Pricing Review on 3 October. A key finding of the review was that the market is largely working and is not in need of substantive reform, but it isn't delivering for everyone.

Where the Government has identified areas where it believes change is required, it has largely turned to the Electricity Authority to deliver, giving the Authority increased powers and an expanded work programme.

We expect the Government's focus on improving competition, transparency and the wholesale market will benefit all consumers.

The price all consumers pay for their electricity is primarily determined by the wholesale market. MEUG has had concerns regarding the performance of the market since spring 2018. Increased information disclosure and transparency will help restore confidence that consumers are not paying more for their electricity than they need to.

**Where next on transmission pricing?**

Submissions are in on the Electricity Authority's draft transmission pricing guidelines. MEUG is reviewing those submissions and we'll finalise our position on whether the cost-benefit-analysis (CBA) is robust in cross-submissions, which are due at the end of the month.

An early impression is the current consultation is shaping up as a battle of the economic experts.

For example, Meridian Energy's experts argue the CBA is robust and provides a basis for moving forward. By contrast, Transpower's economic advisors have a section titled "The quantitative CBA is irredeemably flawed."

The draft guidelines reduce the prescription of the 2016 proposal and give more flexibility to Transpower to revise the transmission pricing methodology. Faced with strong push back from Transpower (and likely others who favour retaining RCPD), it's likely the Authority will hold another consultation round or conference on the CBA with a view towards shoring up its position ahead of judicial review of any final decisions.

With the Government signaling in its response to the Electricity Price Review it will hold off any decision on whether to implement of a Government Policy Statement on transmission pricing until it sees how the Authority's process pans out, expect to see numerous parties on both sides of the debate step up their political lobbying in an effort to influence the eventual outcome.
